MEMBERSHIP: 04.

1)Class of Members:

A) Life long Members/s: Person/s Who shall pay Rs.500/-

B) Ordinary Members/s: Person/s Who shall pay Rs.100/-

(Renewable yearly)

2)Qualification of members:

a) The person/s who are ready to work for the welfare of the Association, not below the age of 18 years.

b) Person/s should not be convictd inprisonment for moral

3) Rights of Members:

a) To attend General/Special Meeting of the Association.

b) To take part in exchange of ideas the meeting/s of the

4) Cancellation of Membership: Cancellation of membership shall be effected autometically on the followings grounds.

6) a) Membership & its Enrolment:

A person having the age of more than 18 year can be a member of the Society who ever wants to become a member has to make an application on personal persona

b) Category of Membership:

ordinary Member: Those who will cotribute Rs. 100/- annually shall be the ordinary member of the society.

Life Member:

One who contributes Rs. 500/- in lump-sum shall be the life member of the society.

c) Rules Reagarding Dismembership:

The managing committee shall pass a resolution in it's meeting for dismembering a memberby 2/3 majority.

- 1) If the remasins absement of 3 meeting consecutively without itimation.
- 2) If his behaviour proves to be harmful in the interest of the Association.
- 3) If his behaviour appears against the rules of Association.
- 4) If the subscriber member not pays the membership fees within 3 months after completion of te year, his membership will be ceased automatically.
- 5) If he found to be unsound minded, bankrupt and imprisioned.

07) GENERAL BODY:

- 1) The generl body meeting of the Association shall consist of all the executive members who have contributed the membership fees.
- Meetings: The first general body meeting shall be held within 12 months from the date of Registration and the subsequent general body will held Once in official year.

- 3) Notice:- A Notice with 15 (clear) days shall be given by the Secretary for initiation to all the executive members, with the copy of agenda, as approved by the president.
- 4) Quorum: 1/3 rd(One third) members of the society shall form the quorum for thegeneral body and no quorum is required for the adjourne general body meeting.
- Decision: All the matters decided either unanimously or by the majority of votes shall be general body shall have a casting vote.
- 6) Presiding over the General Body:- The President or other leading person as determined by the govrning body shall preside over the general body meeting.

08) SPECIAL GENERAL BODY:-

The President of the Sociaty either at his own may invite or in Requesition signed by at least 1/3 rdof the total members of the Association may call the special General Body Meeting, with a 10 (clear) days notice to transact the special business.

09) GOVERNING BODY/BOARD OF MANAGEMENT:

- A) 1) The Affairs of the society shall be vested in the governing body which consist of 15 members of the general body.
 - 2) The governing body elected by the first general body shall hold office for a period of three years from the date of registration as per memorandum.
 - 3) The members of the governing body shall officiate untill they are replaced by the successors.
 - 4) The members elected to the governing body shall in the first meeting elect among themselves, One president, One secretary, the Vice President. Joint Secretary 7 Treaserer.
- B) Meeting: The Governing body shall meet atleast once in a month, if necessary, in the middle.
- c) Notice:- Seven clear days for the ordinary meeting, and special meeting, and three days for the urgent meeting shall be given.
- d) Quorum: Eight members shall form the quorum of ordinary and special meeting and no quorum is however required for the adjourned meeting on the same objective.
- e) Decision: All the matters decided either unanimously or by majority of votes shall be of valid, in case of equality of votes the president or the person who presiding over the meeting shall have a casting vote. The secretary shall record all procedings during the course of meeting.
- Preside over the Meeting: The President shall preside over all the meeting of the governing body and the sub-committee in case if he is absent the members may elect one among themselves, to preside over the meeting on the date.

10) POWER & FUNCTIONS OF THE GOVERNING BODY:

The governing body shall be in sole and exclusive charge of the affairs of the Association, particulary in general exercise of the following powers and functions.

- h) To fix up the honorarium and and TA and DA to the office bearers and the staff members and to solve any dispute in the management and works in consultaition with the financing agencies and also to maintain upto date accounts and record by the secretary and to watch for the proper implimentaition of the activities and the business.
- i) The governing body shall have power to frame the subsidary rules to the general working of the society unsolved problems and be referred to the general body.
- The general body shall have power to check the cash and stocks, at any timer or periodically. j)
- Financial resources for the objects and the activities of the Association shall be raised k) through donation, state and centeral govt. co-operatative/scheduled bank and nationlised bank etc.,
- To remove or take desciplinory action against staff members. D

Power & Duties of Office Bearers: 11)

- To conduct the proceedings of the meeting, of issuue approriate orders for the benefit of the society. To control the proceedings of the society and to give 1) casting vote in the event of equal votes.
- To call meeting of the Society, To make Correspondance, entertain the complaints. - Treasurer: To keep approriate accounts, To prepare final accounts, to collect donations, funds subcriptions and put all the accounts in Governing and General Body meeting.
- Members of Governing Body : To attend the General Body and Governing Body
 Meetings, to vote in the meeting of society.
- 12) President: The president of the secretary shall be responsible to implement the ecisions taken by the execute committee. He shall preside over the meeting of General Body executive Committee and the advisory council. The President shall operate the bank Account any on behalf of the Association or authorised any persons to sign the cheques ontheir behalf.
- 13) Funds:

 a) Funds shall be collected from doners and well wishers of the Association, the funds of the Association shall be spent only for the attenment, of the aims and objects of the Association.

15) AMMENDENTS TO CONSTITUTE:-

Any change in the constitution can be made by 3/5th in General Body meeting Procedure as laid down in he karnataka Societies Registration Act 1960. Shall be followed.

As and when the objects and/or name of the society is to be changed or the society is to e amalgamated wholly with other society, the peocedure laid down in the Karnataka Societies Registration Act 1960. Shall be followed,
