






A Talk on “Legal Awareness for Women” by Mrs. Ujwala Sirnagdouda**

A Talk on “Legal Awareness for Women” by Mrs. Ujwala Sirnagdouda was held at the Seminar Hall initiated by The Women Empowerment Cell and The Prevention of Sexual Harassment Cell of B.L.D.E.A’s S.B.Arts and KCP Science College, Vijayapura. The Talk commenced at 11am on 27<sup>th</sup> February, 2018. The occasion was graced by the honorable Chief Guest Mrs. Ujwala Sirnagdouda, the President of the Talk Prof..S.A,Malwade, and the Chairman of Women Empowerment Cell, Prof. V. R. Patil, and distinguished Faculty Members and the students of all streams.

The occasion began with an invocation song by Shraddha Nayak of BCA Department. Miss Rashmi Patil, Faculty of P.G.Department of English welcomed the dignitaries on the dais and off the dais, and introduced the Chief Guest to the attendees of the occasion.


The prolific and well established Resource Person Mrs. Ujwala Sirnagdouda opened up a new world of legal awareness with her insightful thoughts and knowledge. She began her talk by stating that inequality for equally born human beings is truly a questionable move. Inequality in the every stream of life such as political, economical, social, and cultural fields has gone to such an extent that women now have to fight for even the basic rights. However, the local administrative sectors have allowed reservation of 33% for women which too are a disputable move and the voices have naturally vocalized for the equal reservation as of 50% in all sectors so that women could reach to the equal position of those of men. She stated that fortunately modern time has been gradually realizing the discrimination it meted out on women since time immemorial, and is taking the essential steps to demolish the barriers by creating and promoting various laws which would help women, provide justice to her, and allow her to lead a gracious life confidently.


Later the session is opened for discussion where students asked various questions and got cleared their doubts by Resource Person.






