

## **ANTI RANGGING GUIDELINES**

As per the Hon. Supreme court of India and Subsequent notification from UGC rules and regulations the following are the guidelines:

1. As per the UGC regulation and instructions Anti ragging committee is constituted in the college.
2. Any conduct by any student or students whether by words spoken or written or by any act which as the effect or teasing, treating or handling with rudeness a fresher or any other student.
3. Indulging in rowdy or indisciplined activities by any student which caused or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
4. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing a sense of shame.
5. Any act by a senior student that prevents disrupts or disturbs the regular academic activity of any other or a fresher.
6. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
7. Any act financial extortion of forceful expenditure burden put on a fresher.
8. Any act of physical abuse including all variants of it; sexual abuse, homosexual assaults to fresher or any other danger to health or person.
9. Any act or abuse by spoken words, e-mails, post, public insults to fresher or any other student.
10. Any act that effects the mental health and self-confidence of a fresher or any other student.

### **ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING**

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here as below:

1. The Anti-Ragging committee of the institution shall take an appropriate decision in regard to punishment or otherwise depending on the facts of each incident of

ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging squad.

2. The Anti-Ragging committee may depending on the nature and gravity of guilty established by the Anti-Ragging squad, award to those found guilty, one or more of the following punishments namely;
  - i) Suspension from attending classes and academic privileges withholding/ withdrawing scholarships/fellowships and other benefits.
  - ii) Debarring from appearing in any test/examination or other evaluation process withholding results.
  - iii) Debarring from representing the institution in any regional, national or international meet.
  - iv) Suspension from the hostel.
  - v) Cancellation of admission.
  - vi) Debarring from admission to any other institution for a specified period.
