Curricular Aspects

The curricula also address sensitive gender issues, which are a major and growing concern in our country. Curriculum is enriched with certain other co-curricular Activities for the Students co-relating to other Issues. This is rendered by taking up with the Field Survey, Projects and the Internships that contribute to the Experiential Learning and necessitates the comprehensive development of the Student. The Faculty participation of almost all the U.G. and the P.G. Courses as BOS, BOE in the Parent University and also this service is rendered to other Institutions elevates and focuses the quality of education in the Institution. The Feed back is collected from the Students, Teachers, Employers and Alumni regarding the Curriculum. The analysis of this Feed back is done and accordingly the Action Taken Report is prepared. The Syllabus Workshop for all U.G. Language, Basic and Human Sciences Departments was organised in the College and the suggestions are collected. This follows with the receiving of the suggestions and is processed in the BOS Meetings of the Parent University .

Teaching-learning and Evaluation

The College administers transparent admission process adhering to the norms of the Government and the Policies of the College/University. The Students get acquainted to the College with Orientation Programme /Bridge Course .The teaching process from classroom to the Onsite Project visits/Teacher-Student Exchange Programme/Internship/Guest Lectures/ Conferences /Workshops etc enables the students to understand the concepts of their respective subjects with more appropriateness. The Teaching Faculty's involvement is in enhancing their teaching methodologies by adapting to the ICT modes such as LMS/MOODLE/Smart Boards/TED Talks. Further, the Teaching Faculty motivates the Students to participate in Curricular/Co-Curricular/Extra Curricular Activities. This is further strengthened with varied Evaluation process/Mentorship, assist in evaluating Students' knowledge acquired from the Institution for the dissemination of Teaching and Learning.. All Departments in the Institution identify slow learners and provide multilevel remedial coaching for them. The Programme Outcomes/Programme Specific Outcomes /Course Outcomes for all the Programmes offered by the Institution are stated in the Course Catalogue of the respective Departments.

Research, Innovations and Extension

The Research Environment is created by promoting Research Culture in the College. The Seed money is made available as incentives for the Teaching Faculty and the students alike. This displays the earnestness of the evolving the research logarithm amongst the Faculty of the college. The result of these efforts can be witnessed

in the MRP of total Rs.44,44,578, 131 Publications and Presentations by the Faculty in National and International Journals, Seminars and Conferences respectively. The Faculty is also recognized as Executive Member of the Editorial Board of Reputed International Journal. One of the Faculty Publication has received Best Paper Award in International Seminar, London. The Plagiarism Software, Turnitin is made available to the Faculty for their Research Publications. The Campus is Wi-Fi enabled and has LAN facility with 52 mbps speed.

Institution Level:

The College with respect to the University guidelines and the Action Plan prepared holds the I and II Theory Internal Tests for the Students for 20 and 80 Marks respectively. This further is followed with the format given by the Parent University for the respective Courses. The Practical Exams; Internalsare held by the College and the Externals are held under the scrutiny of the External Examiner appointed by the University . 2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

Response:

The Rules and Regulations for Evaluation process are laid down by the affiliating University and are communicated to students through Orientation Program organized by all the U.G. and P.G. Programs.

The reference of the University Academic and the Examination Calendar of Events are followed by the U.G and the Self Financed –B.C.A.,M.A.(English), M.Sc.(CS) , M.Sc.(Chemistry) and M.Sc.(Physics) Courses. The U.G. Time-Table Committee of the College prepares the First and Second Internal Assessment Test Time-Table. The Internal Test Question Papers are sent to the Committee by the HODs of the respective Departments. The College Examination Committee conducts the Tests for Arts and Science Disciplines by assigning the Invigilators duty for the Faculty of these Departments. The Self-Financed Courses, individually hold the First and Second Internal Tests. The Internal Tests are held again for the Students participating in the Sports Events. The Students are informed of Test Syllabus before the commencement of the Internal Tests. The U.G. Arts and Science Disciplines provide the Institute-labeled Answer Sheets and the Self-Financed Courses provide the Department Blue Books.

The Unit Tests are conducted for the Students by some of the Departments to strengthen their performance in the Internal Tests and Semester-end Examinations. The Assignments are collected from all the Students of the U.G. and P.G. Departments.

The Practical Internal Tests for the Science Streams and the U.G. Social Work Department are conducted according to the Format of the Parent University. The Final External Practical Exam is conducted by the Externals deputed by the University. The P.G. Science Programs for the Self-Study Paper conducts both the Internal and External Theory Examination and submit the Marks to the OASIS.

The B.C.A. and all P.G. Programs' Projects are guided by the Faculty of the respective Departments and they will assess the Individual Project through Presentation and Demo. The Final IA Marks are submitted to the OASIS. Later the External Examiners deputed by the University conducts the Project Viva Voce. The Final Viva Voce for the M.A.(English) is conducted by the Department of University.

According to Parent University Pattern the Final Internal Tests Marks are finalized for 20 Marks. The transparency of the Internal Marks is maintained by,

- The Marks List is displayed on the Notice Boards of the respective Departments.
- Taking the Signature from the Students on the Formatted Sheet.
- The Student Grievances, if any, are maintained in the Register and are attended by the HODs/Coordinators.
- The Final Marks will be uploaded to the University in the OASIS Software Tool.
- From the Academic Year 2019-20 the Internal Marks uploaded in the OASIS can be assessed by the Students in the Student Portal.

Thus these measures create a Mechanism for transparency in the conduct of Internal Assessment Tests.

Courses for the conduct of Examinations with respect to the University Academic and Exam Calendar of Events in the beginning of the Academic Year. This creates a clear analysis for the Students regarding the Test/ Exam preparations.

- The Time-Table of First and Second Internal Tests of all the U.G. and P.G. Courses are made in the beginning of the Semester is displayed on the Website.
- The Internal Practical Tests of the Science Departments are conducted by the respective Departments.
- The U.G. and P.G.Science Departments prepare the External Practical Exam Time-Table according to the Semester-end Exam Notifications and send it to the University.
- The Exam Notifications are displayed on the Notice Boards of Office, Respective Departments and intimated to the Students by the Faculty in the concerned Social Media Groups. The concerned Office Staff of U.G. and Self-Financed Courses are involved in the Exam Form filling process and later the Staff also takes up with the Issues related to Hall Tickets and resolve it. From the year 2018-19 the University has updated the online procedures for the Exam Form filling and the Issue of Hall Tickets is carried out through the Student Portal. The Head of the Institution certifies and thereafter the Students can retrieve the Hall Tickets.
- The Semester-end Examination Time-Table sent by the University is notified to the Students through the Notice Board and Social Media Groups of the respective Departments.
- The Final Internal Marks are submitted to the University as per the criteria set by the Parent University.
- The Student Grievances with regard to the IA Marks is recorded in the Ledger.
- The Project Viva-voce of the Final Year B.C.A./P.G. Programs are conducted according to the University Time Table.
- The Student grievances related to Exams with respect to the Semester-End Results Photo

Copy/Revaluation /Recounting/Challenge Revaluation is followed with the Exam Notifications released by the University and the Documents are accordingly recorded in the Office of the College.

- The grievances are resolved within 10 days by coordinating with the University.
- The Application for the Convocation was earlier processed by the Office of the College and later sent to the University. From the Academic Year 2018-19 this process is carried out through Student Portal. Further the intimation of the Event is given to the student by the College Office.

3.4 Extension Activities

On the basis of the survey, the Programs are prepared in such a way which would help for better educational, socio-medical and health- care awareness among the villagers. The volunteers identify the school drop outs and help them in getting enrolled into the government schools after counseling their parents.

The NCC Unit organizes various Battalion 10 day Camps to train the Cadets for Para-Military and Armed Forces. The selected Cadets are promoted to RDC and TSC. The Cadets participate in the College National Festival Day Parades. Criterion 4 - Infrastructure and Learning Resources

4.1 Physical Facilities

4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Response:

The college has a land area of 9.5 acres in the form of well equipped Classrooms, Laboratories, Library and Computer labs to cater the academic needs of the 2363 students of 03 U.G. and 04 P.G. Programs. There is 01 Girls Hostel to accommodate 320 students. Every year the Time-Table Committee prepares a Time-Table for the Academic Year taking in account the optimum utility of resources available. There are 26 Classrooms with Projectors (Mounted and Mobile), and the entire Campus Wi-fi enabled with 52 mbps Internet Speed, together make the 10 Classrooms equipped with the ICT facilities. There are 03 Seminar Halls in the College with ICT infrastructure which are used for Guest lectures, Seminars, Meetings and Conferences.

The College has in all 21 well equipped Laboratories under various Science Departments and a Language Lab. The B.Sc. Computer Science and BCA/M.Sc. Laboratories together have 80 computers connected on LAN, with wireless and internet connectivity. There are 04 Smart Boards in B C A, Statistics, B.Sc.(CS) and Zoology Departments which are also used by all the Departments of the College according to the requirements for the Study. The new setup of the Language Lab has 20 computers with 01 Server well equipped with the Wordsworth software. Moreover, the lab Timetable is so prepared as to ensure optimum usage of the Language lab and Computer Labs leading to student-computer ratio 1:1.

The Institute has a Central Library having total area of 327.02 sq. meters (1 Floor) with 88345 books and E-lib software .It also has access various repositories (Vidwan, has to IRINS, SCOPUS, ORCID, INFLIBNET). There are separate Reading Sections for the Faculty and Students a separate P.G. Reading Room. In addition, the Departments have a separate Department Library to provide subject related Books and CDs. All the Classrooms and laboratories are spacious as per the specification of the statutory bodies. The Classrooms are of different dimensions adequate to accommodate sanctioned strengths of different Courses. The classrooms are sensor enabled which facilitate to the optimal usage of the fan and light facilities.

The total area of Playground is 30,402 square meters i.e 180 meters length 140 meters width. 400 meters track with 8 Lanes with the facilities of Cricket Ground, Foot ball Ground, Hockey ground, Kabaddi court, Volley ball court, Lawn Tennis court, Tenni koit Court and the kho-kho court. The College has a Multipurpose Sports Hall and one Indoor Stadium with gallery to accommodate 1000 Spectators. The International Standard swimming Pool sanctioned under UGC XI plan of length of 50 x20 meters is made available to the Students. The Swimming Pool has an appointed Trainer.

Facilities for the Yoga and Gymnasium Activities:

The Yoga related activities are conducted in the Open tactile area in the Campus and also in the Open Auditorium. A well-equipped Gymnasium of specification 40 x 30 square ft. Is provided for the Students in the Campus. Recently, the Indoor Stadium inaugurated added up to the facilities of a well equipped Gymnasium and Yoga Halls.

Facilities for the Cultural Activities:

The College has a rich tradition of cultural activities in Theatre, Dance, Music, Literary events and Fine Arts. The College provides necessary facilities for its budding artists. External experts are invited for mentoring and directing the performances.

- 1. An Open Auditorium with seating capacity of 200 students.
- 2. 03 number of Seminar Halls with the following Student seating capacity: Seminar Hall No. 1 with 300, Seminar Hall No. 2 and 3 with 250 and the Open Air Theatre with 200.
- 4. Art Corridors: The Space for exhibition of Fine Arts like Drawings, Posters and Clay Models are taken in the display Corridors of the College which converts these as the Arts Corridors.

Using all the available facilities, our students have won Medals and Trophies at University, State National Level and International level. Our College has bagged "The Samagra Viragrahani Prashasti" (Zonal Championship Trophy) for the Years 2015-16,2017-18, 2018-19 and 2019-20 in Zonal level Youth Festival Competition conducted by the Parent University. The College has also organized various Sports and the Cultural Events and Programmes of National, State and University level.

The Library of the College was established, in 1945, and since its inception, the College Library is a veritable treasure of Rare Books and also has the collection of the Reference Books/ Textbooks/Dictionaries/Magazines/National/International/Review Research Journals/Newsletters and Encyclopaedias. Its total collection presently comprises of 80183 books, 36 Magazines and 22 Journals, 184 bound volumes and 640 CD/DVDs. It also subscribes to 13 numbers of News Papers of which 08 Kannada, 04 English, 01 Hindi Newspapers. The Library, which is under CCTV surveillance, has a spacious separate Reading sections for the Students, Faculty and a separate stacking area. It also has a separate Reading Room for the P.G. Students. It operates under the Open Access System. The 52 mbps speed Internet availability, Wi-Fi connectivity, the facility of 10 Computers is provided in the Internet Centre. In addition 10 Computers are available in the Browsing Centre for the Students which is accessible from 9 am t0 4 pm, Scanning and Photocopying facilities and a 24 /7 UPS Backup are all made available in the Library. The Management has formed a Central Management Committee which visits periodically monitor the Library system.

The Library is open from 7.30 am to 5.30 pm on Weekdays and until 8pm during the Semester-end Examinations. The functioning of the Library is fully automated through an Integrated Library Management System with E-LIB (Version 6.2) Library Automation Software.

The Administration Module is facilitated through the Librarian. The Acquisition and Cataloguing Modules generate Accession/Register the Reports/adds bulk Students Records/updates the items Lending and Status. The Circulation Module handles the Issue/Reserve/Return of Books. It has the capacity to generate Reports regarding Book Borrowing/Item Inventory Status/Circulation Status Summary and Transactions/Library Barcodes are also generated, using this Module. The Serial Control Module maintains Records of Print Journals and tracks Subscriptions.

The Software takes care of Book Renewal and offers search facilities and also provides Online and Offline support for Software-related issues/ Data Backup and Software maintenance through an Annual Membership.

The Moment Register Bar Code Version is maintained for the Check in and Check out of the Faculty and the Students.

An WEB OPAC Search Engine (Public Access Catalogue) link is provided to the Faculty and Students on the Institutional website. The Digital Library Collection, Rare Books, Open Source Books, Question Papers of Previous Examinations etc. are made available through this link.

The D-Space Server has the updates of the Faculty Publications and also the Best P.G. Final Year Academic Project Reports are uploaded in the Server.

The College Library gives access to the N-LIST e-Resources which can be accessed freely. The Vidwan Software enlisted in the Library gives access to the Faculty Profile and their Publication details and also to

the latest updates of the available Library Resources. Recently, the Plagiarism Software, TURNITIN is made available to the Faculty for their Research Publications.

4.3 IT Infrastructure

4.3.1 Institution frequently updates its IT facilities including Wi-Fi

Response:

The Institution has in the last five years updated IT facilities including Wi-fi thereby making Teaching-Learning process intresting and effective.

In the academic year 2016-17, the Institute with a focus to integrate with the e-learning resources purchased two Dell workstation Computers (Tower 3420). In the Computer Laboratory of the Departments of BCA/M.Sc.(CS), the inverter of capacity 6KVA was upgraded to 10KVA. To increase the bandwidth of internet connectivity (ADSL) and wireless accessibility, a Wi-fi enabled modem was purchased.

In the academic year 2017-18, the Institute identified the requirements at two classrooms were equipped with Projectors (existing projectors were replaced due to aging). Moreover, two Projectors (Audio streaming and Wi-fi- enabled) were provided to Departments of Botany and Chemistry respectively. The network has been upgraded to lease line of 10 Mbps.

In the Academic Year, 2018-19, the Institute focused on uniform distribution of network connectivity, purchased necessary components/equipments and upgraded the internet connectivity from ADSL line to lease line of bandwidth 13 Mbps. The Wi-fi enabled two Projectors were purchased and the sound system was upgraded so as to enhance the ICT enabled learning environment. To train students with the basic and hands-on experience on networking, the components namely LAN cable tester, Crimping tool, and cable connectors were added to the Departments of BCA/M.Sc. (CS).

In the Academic Year, 2019-20, the Institute with a focus on the enhancement of the Communication Skills of Faculty and Students established the Language Lab. The laboratory comprises of DELL Power edge T30 Server (Qty -1), N-computing thin clients (Qty -20), 24 port 10/100/1000 Mbps Network Switch (Qty -1) and 5KVA online Inverter.

In the Computer lab, at Departments of – BCA/M.Sc. (CS) and – B.Sc. (CS), The Online power backup systems are upgraded with new Batteries by replacing the deprecated batteries, thereby providing backup of 6 hrs. respectively. The mentioned labs are upgraded with Desktop Computers having CORE i5 9th Generation Processor. Several computer peripherals are consumables and purchased as a part of ICT. To enhance the mode of teaching and increase the effectiveness of learning in students, the Institute purchased 04 Projectors. The institute upgraded the Browsing Center with 01 Server Computer and 01 Computer for the Research Lab. The Institute also upgraded the Internet Connectivity with 52Mbps LEASE LINE and LAN with Wi-fi zone across the campus. Various Departments and Cells were upgraded with Computers and Peripherals during the Academic Year.

- The Browsing and the Internet Centres are open to access from 9 am to 4 pm.
- The separate P.G. Reading Room facility has created an additional quality enhancement in the Learning process of the Post Graduation Studies.
- The qualitative Library of the College is very best utilised by the Students in its Reading sections and can be witnessed with the quantitative login data.
- The separate Reading Section for the Faculty is best availed of by all the Teaching Staff.
- The subscribed various Kannada and English Newspapers are kept in the News Paper Sections of the Library which are read by all the Faculty and the Students.
- The INFLIBNET facility has made the Faculty open to the wide and rich access of the n-number of online Resources.
- Regular up gradation of the Library with the addition of more resources has enabeled quality enhancement of Library Services.

6.2.2 The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment and service rules, procedures, etc.

Response:

The Institution is a part of the Management of the B.L.D.E.Association. A well defined Institutional Organogram with the Employer and Student Friendly Policies and Procedures has made the functioning of the Institutional Bodies effective and efficient.

The Management:

The Management comprises of the President, the Head of the Committee followed by the General Secretary and the Administrator. There are Heads for HR, Finance and IT Departments. The Management exercises the overall supervision of the Institution.

- At Institution-level the Principal as the Administrative Head is directly responsible to the B.L.D.E.Association and it has the Administrator who plays a key role between the Management, the Principal and Staff.
- The Vice Principals assist the Principal. Further the next level has the IQAC which works in the co ordination of the Legitimate Council and the Non-Legitimate Council.

The Legitimate Council has the Governing Committee which is categorized as Academic Council, Board of Studies and the Financial Committee.

The Academic Council caters to all the Academic related activities right from Administration to the engaging of the Classes to the conduct of the Examination .

The Employee Appraisal System is a process whereby the Management evaluates and provides Feedback on Employee Job satisfaction.

The Appraisal System instituted for the Teaching and the Non Teaching enhances the overall Skills of the respective Staff.

Feedback:

The Manuals were collected for the Feedback in the Year 2015-16 and 2016-17. The Head of the Institution collects the Feedback of the Faculty from the Students. After the Analysis the Action Taken Report is accordingly prepared.

Self Appraisal:

The Institution from the Year 2017-18 has followed the Self Appraisal System(SAS) implemented by the Association's Standard Operating Procedure's Cell (SOP).

The SAS survey involves the Principal/HODs/Teaching Staff/Librarian/Physical Education Teachers /Non Teaching Staff wherein different attributes are set to all the above mentioned cadres. The Academic/Professional Skills exhibited, the involvement in Extension Activities of the College to be submitted along with the relevant Documents.

The Principal/HODs/Programme Coordinators have to remit their contributions to the attributes of Development of innovative system for improving the administration / academic quality of institution/department, Teaching and Research Innovation/ Reforms introduced at institutional/department level and Institute /Department's Best Practice. It also includes the other Administrative responsibilities, Service to the Institution, Service related to Profession and Public Service/Social Service.

The Teaching Faculty Assessment is divided into two sections: Faculty with experience of more than 8 years are monitored on the framework of Evaluation of academic excellence, professional excellence, Students feed-back for faculty, Examination results, Publications, Research Grants/Funded Projects & Consultancy. Faculty with experience of less than 8 years are monitored on the framework of all the above criteria except with the relaxation of Research Grants/Funded Projects & Consultancy.

The Librarian's assessment here is measured on the parameters of Academic Excellence, Users Feed-back for facility and Service Evaluation, Publications and Best Practices followed as per NAAC guidelines.

The Office Staff Assessment is carried out with the attributes of Skill Up- gradation and Department Examination for Knowledge up-gradation and Promotions.

The Assessment of all the above, accredits the Principal Evaluation arena wherein the credits are earned by the Staff on the basis of the participative tendency and its result output.

The Physical Director is completely assessed by the evaluation of the Principal on the basis of Knowledge up gradation, punctuality, Students Training, organising Supervision & maintenance of Sports facilicties.

The Credits allocated for each attribute is further assessed by an Expert Team appointed by the SOP Cell wherein the Self Appraisal filled Forms are evaluated on the basis of the Scale Bar for Performance Evaluation taking into consideration of the quantitative and qualitative measures.

The Yearly achieved Targets set in the Appraisal Forms are calculated of Individual Faculty and the Cell further sends the evaluated Results to the Management. The Results and the Action Taken Report is sent to the Principal and the incremental growth is expected of all the Teaching and the Non Teaching Staff.

6.4 Financial Management and Resource Mobilization

6.4.1 Institution conducts internal and external financial audits regularly

Response:

The College conducts the Internal Audit and the External Audits regularly. The FDA of our College keeps into account all the financial matters.

The Account Section of the College is under the Finance Section of the Management. The Management has appointed the Chief Finance Officer who is the Head of all the Account Sections of all the Institutions under B.L.D.E.Association.

The regular check of all the Accounts is done by the Chartered Accountant at the end of the Financial Year the Internal and External Audits are conducted by the College.

The Principal takes the consultation of account section to prepare the default budget followed by the suggestions of the HODs. At the beginning of every Academic Year the Budget is made with regard to the Academic, Co-Curricular and Extra Curricular Activities and amount is allocated for these activities.

The proposals related to the Infrastructure development/ IT related requirements/ augmentation prepared by the HODs of all the Departments and various Committees of the College with the consent of the Principal are forwarded to the Account Section and from there the Proposals are forwarded to the Management's Respective Sections.

Internal Audit

The institutional accounts are maintained in Finance Section as per the guidelines issued by Karnataka Government /UGC and various funding agencies in the prescribed format. The annual meeting at the Management Office at the end of every financial year approves the budget estimates for the next year and analyses the actual expenditure incurred during the year under various heads.

Guidelines followed for the preparation of budget:

- The Management verifies with the fee collection of the UG and Self Financed Courses and also verifies the collection and accounting of other revenue such as consultancy, grants, donations etc.
- The vouchers related to all the expenditures are verified by Charted Accountant, audited accounts are consolidated, compiled and filed with Income Tax Department.

External Audit

External financial audit is carried out by an external agency appointed by the Management as well as by the Government bodies.

The Management appoints an external auditor for the conduct of audit of accounts . He verifies all the vouchers with reference to the cashbook and prepares the balance sheet. Transparency is reflected as no major objections being ound during the last five years.

6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Response:

The operating budget of the Institution is adequate for its day-to-day expenses and maintenance of infrastructure. The Institution makes efforts to mobilize additional financial resources for infrastructure development /Teaching-Learning /Research/other activities.

At the commencement of every Academic year, the Principal allocates the Budget to the various heads of expenditure by taking Approval from the Management by forwarding through Account Section of the

College.

The priority of the requirements expenses as per the Budget are monitored by the Principal and Accounts Section and as per the requirement at times changes are made accordingly and the demands are attended. The Account Section holds for the Internal Audit at the end of every Financial Year. The Chartered Accountant appointed by the Management does the yearly Audit of all the expenses.

The Institution has certain strategies for mobilization of the Funds are generated through available Resources.

The Faculty of the U.G. Department of Chemistry are involved in Consultancy. The Consultancy in terms of the Soil and Water Testing generates the Funds and these Funds are entirely donated to the College which further is utilized for the development of Research activities of the College.

The College Infrastructure is used for the Competitive/Government /CET Exams and the various Government-level/ NGO Programs are organized in the Seminar Hall of our College .The revenue generated from these sources are utilized for the developments of the Physical Infrastructure .

There are two Sections viz The Vijaya College Society and the Institute's The Institute's Society provides the Students with the Science Lab Manuals, Blue Books, I.A. Answer Scripts, Stationeries etc and the Fund generated here is used for the maintenance of the Society and the Infrastructure developments.

The Funds generated by the Women Empowerment Cell by organizing the Stall Fest in the College is utilized for the Cell's Activities.

The Fund generated from Canteen is utilized for the development of the Physical Infrastructure.

The Fund generated by the Xerox Centre of the Institution is utilized for the maintenance of the Centre and for the developments in the Infrastructure.

The resources available of the Gym , Printing Press and the SBI Branch facilities are utilized by the College.

The Funds generated by the International/National/State level Seminars/Conferences/Workshops organized by the College are again used for the developments in the Research activities which involves in providing for the financial support to the Teachers and the Students for attending the Seminars/Conferences/Workshops or publish the Research Articles.

Response:

The Institution has instituted facilities to manage the degradable and non degradable waste generated in the College. The College takes certain measures so that the 'Best' can be attained and managed even from the waste.

Solid Waste Management:

The Institution implements Solid Waste Management by enforcing the waste segregation rules . Dustbins are places in Laboratory, Department Staff Room, Ladies Room, Women Fresh Room, College Canteen and at different locations in the Campus. The peons are allotted with two Class Rooms each and corridors to maintain the cleanliness and the Sweepers are allotted to sweep the entire Campus and manage all the waste generated in the campus. The dry dead leaves from the trees are collected separately in the Vermicomposte. Every year the solid waste in the form of Newspapers, broken Iron Benches or any other wornout materials from laboratories are given away to the vendors. These vendors are hired on contract basis by our Association. The Fund thus generated is used for the maintenance of garden.

Liquid Waste Management: The waste water from the bathrooms, all science laboratories, sinks in the college or kitchen of the College Canteen and Water Purifiers are connected through a pipeline to a Waste Management Pit. The water is treated here and this water is used for gardening purpose.

Biomedical Waste Management: The biomedical waste of the eggs is used for the Lab Practicals in the Zoology department (Due to the ban on the detection of the insect or animals). The eggs used in the lab are further disposed and buried in the pit meant for the biomedical waste.

E-Waste Management: The E-Waste generated in the college in the form of computers, Printers, Batteries, Stabilizers or any other Electronic Gadgets are disposed to the vendors who are in contract with IT Department of the Management. The Fund generated from these is used for the developments of Physical Infrastructure.

Waste Re-Cycling System: The college with lush green campus has wornout and broken wooden benches , chairs, tables. These are dumped in the huge pit and allowed to decompose for processing the Vermicompost which is used for the garden.

The Institution thus manages all waste generated in the campus very judiciously and the Fund generated is used for the developments in the physical infrastructure/Garden/fulfilling IT requirements.

4.The Practice

The TED Talks have brought about the incremental growth with regard to the Teaching and Learning process.

6.Problems Encountered and Resources required:

The introduction of this practice witnessed initial hurdles . The first was the time limitation set for these Talks by TED as maximum 18 minutes. Also apart from this the medium of instruction was English. The accent was British / American which was difficult to follow for our Students. Later, the area of location of our College which is considered to be having certain inhibitions for using English in the spoken form and also the Programmes of Arts with Humanities and Languages (which includes the vernacular languages) all together posed as the challenges. This was later successfully addressed with the explanation of the concept, before screening of the Talk by the Faculty. This made them get acquainted with the topic explained and also the Talks with the subtitles made the students to understand the content of the Talk.

This Best Practice of our Institution has created a scenario of upgrading of the knowledge with Technology. The globalization of the thoughts and the spreading of the new ideas can be catered with this practice. This Center is a non profit establishment and offers a unique goal of teaching Sanskrit language to Boys and Girls or Men and Women from the social order apart from the Students / Staff of our College.

Sanskrit also facilitates a better grasp of the mechanics of other languages and scripts. **Sanskrit** opens the mind to a wide variety of concepts, making the learners liberal in their views. **Sanskrit** helps in the growth of consciousness and has immense power in bringing a greater transformation and connecting us with our rich Culture and Tradition.

4.The Practice:

Sanskrit is a cultural language. Learning of Sanskrit language enriches one's life. It is one of the treasures which India has gifted to the world. There are certain myths which hinder the learning of Sanskrit language such as Sanskrit is a difficult language and is spoken by a specific class. The institution commenced Spoken Sanskrit classes in order to disapprove the myths as baseless. Thus, a unique approach is undertaken for the proficiency in Sanskrit language and to develop speaking skills of divine language by the Department of Sanskrit.

The Sanskrit Sandhya Kendrais operational in the Institution from the Academic Year 2010-11. This is the Best practice of the Sanskrit Department which ultimately is also the Best Practice of our College.

This is a practice which creates the scenario of perfection in the spoken Sanskrit language for its entrants in 10 Days.

The College advertises through Newspaper Flex Boards , Handouts , Banners , Local TV Channels and through sending $\,SMS$ on the Mobiles .

The Students of all age groups are inducted in these Classes and may vary from a school going child to the Home- Makers, Businessmen or the Government and Private Employees. The classes are held in the College Premises from 5.30pm to 7.00p.m.

The Classes are held for First and Second Level in this Kendra. In the First Level, the teacher makes effort to make the students speak a few broken Sanskrit Sentences which are useful in our day to day context. The student is also made to write Sanskrit through Devanagari Script. The course is a three months certificate course with Academic up-gradation of PRATHAMA DIKSHA & (Vyavaharavatarani), DWITIYA DIKSHA (Vyavaharagahini).

Our College is conducting Pratham and Dwitiya Diksha courses since 2002-03 more than 500 students from various fields such as Teachers, Doctors, Engineers, Lawyers, Businessmen, Children and Home-Makers have developed skill in speaking Sanskrit language.

The Students of the Kendra have registered the use of this language in their daily to day life thereby making it a means of their communication.

The Students of this Kendra have further created the importance of learning the spoken language and framed a Sanskrit speaking community. Here in Vijayapur, many localities are having Houses/Business Counters where the language of communication is only Sanskrit.

5.Evidence of Success:

This practice has helped the Students

- To converse fluently in Sanskrit.
- In creating a hub of Sanskrit Speaking Community The Students demonstrate skits, role plays, episodes from Shakuntala in Workshops / Seminars.
- The students are being honored by Sanskrit Academy for conversing in Sanskrit.

- Irrespective of Class and Caste Spoken Sanskrit is learnt .
- The students can sing songs in Sanskrit.
- It has also helped the students to seek appointment as teachers in Primary, High School and Junior Colleges.
- Some of the students have become Priests in temples .
- Some of them are conducting tutorials.
- The Sandhya Kendra has trained 120 students in the last 04 years.

The Student of our Kendra, Shri Ramasingh R. Rajput was entitled as 'Public Hero' in one of the famous 'Public TV' Channel Programme for his contribution in enlisting this language to regain its former glory.

The Sanskrit is not a Mother tongue in this present scenario and hence its not so easy to convince to be the Students for this Language. This language is the Mother of almostall the Indian languages. But yet the prominence is notwell composed for the use of this language in the Public strata of the Society.
